

ORDINANCE NO. 721

The following ordinance was offered by W. C. Martin and seconded by S. T. Evans, at a regular meeting of the Mayor and Selectmen of the Town of Homer, Louisiana, on June 4, 1984, to-wit:

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE TOWN OF HOMER, LOUISIANA

WHEREAS, on August 29, 1983, WILLIAM LYNNTON ETHRIDGE and SUSAN GRIFFON ETHRIDGE presented a petition to the governing authorities of the Town of Homer, Louisiana, requesting that certain property described in the petition be included in the city limits of the Town of Homer, Louisiana; and

WHEREAS, it was determined by a certificate of the Tax Assessor of Claiborne Parish, Louisiana, that the said WILLIAM LYNNTON ETHRIDGE and SUSAN GRIFFON ETHRIDGE were the sole owners of the property sought to be annexed; and

WHEREAS, a notice of said petition for annexation was duly advertised in The Guardian-Journal, the official journal of the Town of Homer, Louisiana, on September 1, 1983, and that no objection has been filed with regard to the said annexation and more than ten days have elapsed since the date of said publication;

NOW, THEREFORE, BE IT ORDAINED BY THE MAJOR AND Selectmen of the Town of Homer, Louisiana, as follows:

SECTION I. That the following described property be, and the same is hereby, annexed to the Town of Homer, Louisiana, and made a part of the corporate body of the Town of Homer, Louisiana, to-wit:

A certain tract or parcel of land lying in the N $\frac{1}{2}$  of Section 27, Township 21 North, Range 7 West, Claiborne Parish, Louisiana, containing 20.65 acres, more or less, more particularly described as follows:

Commence at a 2 inch iron pipe found marking the Northwest corner of NW $\frac{1}{4}$  of NE $\frac{1}{4}$ , Section 27, Township 21 North, Range 7 West, Claiborne Parish, Louisiana and run due East for a distance of 606.52 feet; thence run due South for a distance of 683.49 feet to an iron shaft set at the intersection of an old fence and the west side of Dutchtown Road and the POINT OF BEGINNING; thence from said POINT OF BEGINNING run North 89 degrees 50 minutes 48 seconds West, more or less along said old fence, for a distance of 1474.17 feet to an iron bar found marking the Northwest corner of herein described tract; thence run South 00 degrees 50 minutes 50 seconds West, more or less, along an old fence, for a distance of 619.08 feet to an iron pipe; thence run South 38 degrees 30 minutes 00 seconds East for a distance of 513.69 feet to an iron pipe located on the west side of Dutchtown Road; thence run North 51 degrees 39 minutes 18 seconds East along the west side of said road for a distance of 650.65 feet to an iron pipe; thence run North 52 degrees 04 minutes 25 seconds East along the west side of said road for a distance of 454.39 feet to an iron pipe; thence run North 45 degrees 20 minutes 38 seconds East along the west side of said road for a distance of 211.61 feet to an iron pipe; thence run North 37 degrees 53 minutes 35 seconds East along the west side of said road for a distance of 234.94 feet to the POINT OF BEGINNING and being subject to the rights-of-way of all existing utilities and being further shown by a plat prepared by Mason Surveying, Inc., West Monroe, Louisiana, and being made a part hereof.

SECTION II. Be it further ordained that this ordinance shall become effective thirty (30) days after its publication in The Guardian-Journal, pursuant to Revised Statutes 33:172.

SECTION III. That all orders, resolutions and ordinances, or parts thereof, in conflict herewith be, and they are hereby, repealed.

This ordinance having been submitted and each Section read and considered on Monday, June 4, 1984, at the regular meeting of the Mayor and Selectmen, a vote was then taken thereon as follows:
