TITLE: A RESOLUTION AUTHORIZING THE MAYOR TO COMPLETE AND SUBMIT AN APPLICATION FOR A GRANT FOR FUNDS FROM THE LOUISIANA GOVERNMENT ASSISTANCE PROGRAM (LGAP).

WHEREAS, the Mayor and Board of Selectmen for the Town of Homer, Parish of Claiborne, State of Louisiana, wish to apply for a grant of funds from the Louisiana Government Assistance Program (LGAP) to purchase a new vehicle for the Homer Police Department.

WHEREAS, the proposed LGAP funding will be used for the Police Department to replace vehicles that due to wear and tear, age, and high milage, need to be replaced. This will better enable the Homer Police Department to better meet the needs of the residents of the Town.

WHEREAS, the purchase of a new police vehicle will directly and beneficially impact both officers and residents of the Town of Homer by addressing deficiencies related to deterioration, age and high milage of aging vehicles.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Selectmen, in its regular monthly session convened, this 8th day of February 2021 that they do hereby authorize and fully support the application for CWF funds in the amount of \$35,000, and do authorize the Mayor of the Town of Homer to execute the application.

BE IT FURTHER RESOLVED that all resolutions or parts thereof in conflict with this resolution are hereby repealed.


