TITLE: A RESOLUTION AUTHORIZING THE MAYOR TO COMPLETE AND SUBMIT AN APPLICATION FOR A GRANT FOR FUNDS FROM THE COMMUNITY WATER ENRICHMENT FUND (CWEF) PROGRAM.

WHEREAS, the Mayor and Board of Selectmen for the Town of Homer, Parish of Claiborne, State of Louisiana, wish to apply for a grant of funds from the Louisiana Community Water Enrichment Fund (CWEF) Program to upgrade our water meters to the R900I Frequency.

WHEREAS, the proposed CWEF funding will be used to upgrade our water meters to the R900I Frequency, this will allow all meters to be read with the new recommended technology.

WHEREAS, these improvements will enable meter readings to be applied to billing accounts more quickly and efficiently. Ultimately, it will give residents a greater window of time to make funds available to pay their water bills prior to the due date.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Selectmen, in its regular monthly session convened, this 8th day of February 2021 that they do hereby authorize and fully support the application for CWEF funds in the amount of \$35,000, and do authorize the Mayor of the Town of Homer to execute the application.

BE IT FURTHER RESOLVED that all resolutions or parts thereof in conflict with this resolution are hereby repealed.


