- The Louisiana Constitution of 1974, as amended, in Article VII, Section 14(C), provides that for a public purpose, the state and
 its political subdivisions may engage in cooperative endeavors with each other and with any public or private association,
 corporation or individual.
- The Louisiana Constitution of 1974, as amended, in Article IX, Section 1 provides that the natural resources of the state, including air and water, and the healthful, scenic, historic, and esthetic quality of the environment shall be protected, conserved, and replenished insofar as possible and consistent with the health, safety, and welfare of the people.
- 3. The operating costs and deferred maintenance and replacement of assets at Customer owned and operated Locations places a substantial financial burden on the Customer and exposes the Customer and those Locations to risks that materially and adversely impact the Customer's ability to conduct its business and satisfy its commitments and obligations.
- This project is for the public purpose of upgraded water meters that comports with the Customer's governmental purpose for which the Customer has the legal authority to pursue.
- 5. The USA Payments are not gratuitous because the Customer is using and operating the Units.
- 6. The Customer has a demonstrable objective, and reasonable expectation of receiving a benefit or value at least equivalent to the amount expended, as the USA Payments are for significant improvements to the Locations in the form of water meters that are utilized by the Customer's citizens and improve the natural resources of the State of Louisiana and the healthful, scenic, historic, and esthetic quality of the environment, consistent with the health, safety, and welfare of the people.
- 7. Expected Use at Full Capacity is defined as the maximum number of additional connections that the project, as configured, could accommodate before incremental equipment (i.e., collectors) would be needed. Based on the current project scope of 1,696 total Meters and 2 Collectors (925 meters per collector), the estimated total number of meters per collector will be approximately 848 given the layout and geographic footprint of the Town of Homer.
- 8. The cost of the property and liability insurance pursuant to Section 5.3 of the General Terms and Conditions shall be \$160 per month until such time as Customer obtains its own insurance policy and provides a Certificate of Insurance to the SP Entity pursuant to Section 5.3. This amount will be added to Customer's monthly invoice.
- 9. The USA Payment shall be made pursuant to the Authorization Agreement for direct ACH debits and credits.
