**APPROVAL OF MINUTES FOR REGULAR MEETING DATED JANUARY 13, 2020.**

Minutes from regular meeting January 13, 2020 were unanimously approved by council.

**PUBLIC COMMENTS:**

Linda Mozeke who resides at 912 Howard Drive, asked exactly what was the Bond Assessment Fee and was it necessary to increase the fee at this time? Mayor Dr. Xanthe Seals explained to Ms. Mozeke what the Bond Assessment Fee was to best of her knowledge. Mr. Jimmy Hagan was on for presentation but couldn't make the meeting. Mr. Gene Coleman also spoke to give more detail on the Bond Assessment Fee. Linda Mozeke also asked does increasing the Bond Assessment Fee have anything to do with the Budget crisis the Town is in? Mayor Dr. Xanthe Seals stated to Ms. Linda Mozeke the Town was not in a budget crisis.

Timothy Bridges addressed the Mayor and Council about his concerns on Carter Drive with the sewer backing up when it rains heavy. Also speaking was Travine Burks, who resides at 400 Carter Drive, also addressed her concerns about the same issue. Mayor Dr. Xanthe Seals told them we do have solutions to get it done properly and not just patch the problem and getting it done soon.

Elicia Armes who resides at 868 Edgewood Drive, had concerns on her water bill being high. She also stated how hard it is now to pay the bill and with the increase it will be a financial burden.

Brad Rogers, who resides at 111 Maple Street, addressed the Mayor and Council about not having water at his house about three weeks ago. He stated his neighbors had water and his house was the only one with no water, He had concerns on why, when he knows his bill was paid and why bills are so high. Mayor Dr. Xanthe Seals stated to Mr. Rogers that she didn't know why his meter was off and if anyone have any concerns about their bills to please call the office. John Poss who resides at 944 North Main didn't understand how the company that installed the new meters were able to leave with so many not working. Mayor Dr. Xanthe Seals told him she wouldn't know because it was already done before she took office. Mr. Poss also stated information giving about the Bond Assessment Fee from the previous administration and wanted to know what changed from then to now on increasing the fee after it was stated that \$5.00 would be enough.
